Additional Compliance Details

MATERIALS PROHIBITED IN THE GARBAGE

Materials that must be recycled under the ordinance include cardboard, newspaper, white paper, mixed recyclable paper, recyclable glass food and beverage containers, metal (aluminum and steel) food and beverage containers, PET (#1) and HDPE (#2) plastic bottles (including non-food/beverage containers). Note, there may be additional materials accepted for recycling in your city.

Compostable materials that must be placed in an organics bin include discarded food, compostable (food-soiled) paper, and plant debris (includes grass, leaves, shrubbery, vines, and tree branches).

RECYCLING AND/OR ORGANICS SERVICE REQUIREMENTS

Containers and service must be sufficient in number and/or size, and/or collection frequency to capture all of the materials generated. Outdoor containers must be marked as recycling, organics, or garbage with prominent signage on or near them. If you received a violation for "failure to have recycling and/or organics collection service," and you had the required services on the inspection date, it is possible our records may be out of date or in error. Recycling and/or organics service must be documented to avoid future fines. Visit www.RecyclingRulesAC.org/CRS to submit service documentation or a Certification of Recycling Service form. ANNUAL EDUCATION REQUIREMENT

At least once a year, property owners/managers must inform employees, tenants, and contractors of the law and how to properly compost and recycle. Tenants must also be reminded about proper composting and recycling no later than 14 days after move-in and no less than 14 days prior to move out. Keep documentation of the educational materials, distribution date, and recipients for possible future inspections.

Note: Violations of prohibited materials in the garbage correspond with ACWMA Ordinance sections 2012-01.4(a) and 2008-01.4(a), prohibited materials in the in the recycling or organics with section 2012-01.4(b), and failure to have recycling or organics service with section 2012-01.5(a)&(b). The fine amount must be paid as specified on page 1. Failure to do so may result in additional fines and charges.

How fines are assessed: Fines are assessed at an amount not to exceed \$100 (first violation), \$200 (second violation within one year), and \$500 (each additional violation within one year). Note that a sorting violation is assessed as a single violation occurring on the day of inspection while failure to have collection service is fined at \$5/day multiplied by 30 days (\$150). Future violations could be assessed a higher fine amount.

Right to Appeal: You have a right to appeal this Citation within thirty (30) calendar days from the date of the Citation. An appeal must be submitted in writing and mailed to "ACWMA – Citation Processing Center" at P.O. Box 7275, Newport Beach, CA, 92658-7275. An appeal form is available at www.RecyclingRulesAC.org/citations. You must include an appeal fee in the amount of the Fine Amount shown on page 1. After receiving the written notice of appeal, a date, time, and place for the Administrative Citation hearing will be scheduled. You will receive written notice of the date, time, and place of the hearing at least ten (10) calendar days prior by Certified Return Receipt U.S. Mail or process service.
