Multi-Family Complexes Must Also Recycle

Apartment buildings and other multi-family complexes must also begin mandatory recycling. Facilities with five units or more must provide a level of recycling service that is adequate for the amount of recyclables generated.

Property owners/managers must provide recycling information to tenants when they move in or out, as well as annual reminders. Clearly labeled signs or posters near recycling containers must explain how to properly separate and store cans, bottles, cardboard and other recyclables.

Mandatory Commercial Recycling Is Here

Union City businesses and multi-family property owners should be aware of new state and local recycling requirements that go into effect this summer. California's new Mandatory Commercial Recycling regulations apply to businesses that generate more than 4 cubic yards of commercial waste per week and to multi-family residential dwellings of five units or more. If you qualify, you must arrange for recycling services by July 1. Businesses can meet the recycling requirement in a variety of ways, such as signing up for regular recycling collection provided by Union City's exclusive haulers, Allied Waste Services and Tri-CED Community Recycling.

In addition, Union City recently joined most other cities in Alameda County in approving a local mandatory commercial recycling ordinance. It specifies which materials need to be recycled, such as paper, cardboard and beverage/food bottles and cans. It also requires businesses to obtain a level of recycling service that is adequate for the amount of recyclables they generate. Many businesses in town are already saving time and money by participating in Union City's single-stream recycling program, which eliminates the need to separate recyclable materials. Cans, plastic bottles, paper products, etc. all go into the same cart or bin, which makes recycling easier than ever before.

In 2014, all businesses will be required to recycle (not just those generating four or more cubic yards of waste per week) and organics such as food and compostable paper will be added to the list of mandatory recyclables. Get a head start by signing up for Union City's Food Scrap Recycling for Business program, which is already popular with many area restaurants, grocery stores and other businesses.

The City is promoting mandatory recycling through a business assistance recycling program. Businesses can request a waste evaluation to identify where they can recycle more and reduce waste. Thanks to discounted rates for recycling, a business could lower its waste collection costs. MANDATORY RECYCLING AT-A-GLANCE

When does it go into effect:

- Effective July 1, 2012
- All businesses with at least 4 cubic yards of solid waste per week
- All multi-family complexes with 5+ units
- Includes paper, cardboard, plastic/glass/metal bottles and cans
- Implementation costs are usually minimal
- Disposal costs may decrease thanks to discounted recycling rates

Union City collects a mandatory multi-family recycling fee, and most complexes already have basic recycling services. Services that can improve recycling efforts or help start a new program include:

- On-site visits to assess your recycling concerns and solutions
- Educational materials for tenants
- Signs and posters for recycling areas
- Union City Recycles buddy bags to easily store and carry recyclables
- Assistance from Tri-CED's Green Team

Bag Ban

On January 1, 2013, stores in Alameda County that sell packaged food will no longer be able to distribute single-use plastic bags at the checkout stand. Recycled content paper bags may be provided, but only if the retailer charges customers 10 cents per bag. Shoppers are encouraged to **"Bring Your Own Bag."**
