## NOTICE: State and local laws require your business to recycle and compost

Under State of California law AB 341, most businesses and institutions are required to recycle. Beginning September 15, 2020, State law AB 1826 requires all businesses and institutions that generate two or more cubic yards of solid waste per week (garbage and recycling service volumes combined) to also have organics collection service for compostable materials such as food scraps, food-soiled paper, and plant debris.

Our records indicate that your business [Site Name] located at [Site Address], [Site City] may not have the required recycling and/or organics collection service. Note: Businesses that share service, self-haul materials to a recycling/composting facility, back-haul materials to another location where they are recycled/composted, or contract with a third-party for recycling and/or organics collection, must submit documentation at www.RecyclingRulesAC.org/CRS.

In addition to having the appropriate collection service, the Alameda County Mandatory Composting and Recycling Law requires businesses to sort their waste into the proper containers.

- Organics: Food scraps, compostable paper, and plant debris ONLY. No garbage or recycling.
- Recycling: Bottles, cans, paper, and cardboard ONLY. No garbage or organics.
- Garbage: Garbage ONLY. No organics or recycling.

**Enforcement:** In light of the impacts COVID-19 has had on businesses, no fines are being assessed at this time. Take corrective action now to avoid fines when enforcement resumes in the future.

**Do you have recycling bins for customers?** State law AB 827 went into effect July 1, 2020 and requires businesses and multifamily properties to provide customers with recycling and/or composting containers adjacent to each garbage container. Bins must be clearly labeled with educational signs.

# Step by Step: Setting up Recycling and/or Organics Collection Service

# Comply with the law and save.

Most of what businesses throw away as garbage is actually recyclable or compostable. San Leandro businesses are eligible to receive one free recycling and organics cart. Additional recycling service is 80% of the cost of garbage, and organics is just 60% of the cost of garbage. Here's an example of how sorting your materials properly can pay off:
