

MULTI-FAMILY PROPERTIES (5+ units) **AND ALL BUSINESSES** in Fremont must keep their recyclables separate from the garbage.

ENFORCEMENT EXPANDS January 1, 2015.

ACWMA ORDINANCE 2012-0

Attention Fremont Property Owners and Managers:

The Mandatory Recycling Ordinance of the Alameda County Waste Management Authority (ACWMA) now requires all businesses and institutions in the City of Fremont to participate in recycling programs as of July 1, 2014. Recycling has also been required since July 1, 2012, of multi-family properties with 5 or more units.

Requirements to collect organics (food scraps and compostable paper) separately from garbage are also part of the Ordinance. Staff from the City of Fremont, or its franchised waste hauler, Republic Services will be contacting businesses regarding composting for business requirements.

This letter is to notify you that, beginning January 1, 2015, ACWMA will expand active enforcement of the Ordinance to determine compliance. Enforcement activities will expand to include all businesses, not just those with 4 or more cubic yards of weekly garbage service. Violations could result in a citation and fine.

FOLLOW THE LAW TO AVOID POSSIBLE CITATION AND FINE

Property owners and managers of multi-family properties with five or more units and commercial properties may be cited and possibly fined for the following violations:

- Failure to provide containers and collection service for recyclables of sufficient number, size and/or collection frequency to handle all of the recyclables generated at that location. Materials that must be recycled include: cardboard, newspaper, white paper, mixed recyclable paper, recyclable glass food and beverage containers, metal (aluminum and steel) food and beverage containers, PET (#1) and HDPE (#2) plastic bottles.
- 2. Failure to provide information at least annually to employees, tenants and contractors describing how to properly use the recycling and garbage containers, as well as no later than 14 days after move-in and no less than 14 days prior to move-out.

Businesses and institutions may also be cited, and possibly fined for:

- 3. Disposing of recyclable materials in the garbage.
- 4. Disposing of garbage in the recycling containers.

SETTING-UP COLLECTION SERVICE

Contact your service provider to set up collection service. Online resources, including contact information for your city's service provider are available at www.RecyclingRulesAC.org. Online you will also find:
